Those members wishing to participate are required to submit an application. Artists participating last year must also submit an application. Tamarack artists are considered juried in, but must also submit an application. Artists participating in 2019 and Tamarack Artists need not submit images of their work.

All non-members of Artistry on Main are required to submit:

1. A completed and signed application form for each medium.
2. Three to six .jpg images of recent examples of work in each medium in ready to sell condition.
3. Vendor booth fee of 50.00 per table plus 10.00 if electricity requested.

I have read and understand the rules pertaining to exhibiting, for sale, products I have made/created at the Spring into Art Festival 2020. I understand that the Festival is a juried event and my application does not automatically result in acceptance and that the decision of the Jury Committee is final. Artistry on Main reserves the right to limit the number of vendors by medium in order to ensure diversity. I have included my entry fee of 50.00 per table (10.00 additional if electricity requested) booth by check. Checks will be deposited upon acceptance agreement by both the Vendor and Artistry on Main.
