Steve Warner (WVWC '90)

Bobcats Head Coach

Coach Warner is entering his 30th season with the Bobcats. He spent two years as Assistant Coach and took the helm in 1993 as Head Coach. The Bobcats have won eighteen WVIAC Tournament titles and four Mountain East Conference titles. In 29 years, Warner has guided his Cats to an overall coaching record of 1095-408-1. Coach Warner and the Lady Bobcats had a historic season last year. Last years quad was the first team in school history to make it to the Division II College World Series.

Vickie Rohr (WVWC '17)

Assistant Coach

Coach Rohr is in her 5th year of coaching with the Bobcats. At WVWC, she works with the outfielders and pitchers. She played 2 seasons at WVU Institute of Technology. She has been a travel ball coach in WV for over 20 years.

Sara Scoone (WVWC '18 GSC '21)

Glenville State Head Coach

Coach Scoone enters her 2nd season as head coach at Glenville State College. In her first season, she and GSC achieved a record high in conference wins since 2013. A native of Naples, Florida, Scoone played softball at WVWC from 2014-2018. She competed in 3 straight Super Regional competitions, 4 straight Regional competitions, 4 straight MEC Conference Tournaments, while winning 2 MEC Championships. She was a two-time MEC 2nd team All-Conference player, and competed in the 2017 NCAA DII National Tournament finishing 3rd in the Nation. She was part of the WVWC coaching staff from 2018-2020 while earning her MBA.

Assistant Coach
